Every citizen has the right to adequate health and also an important medical record in order to know the disease suffered, because a medical record is very important for every patient to know various health efforts for the entire community through the implementation of quality and affordable health development for the community. Health development is aimed at increasing awareness, willingness and ability to live a healthy life for everyone in the context of realizing an optimal degree of health as an element of general welfare as referred to in the Preamble to the 1945 Constitution of the Republic of Indonesia.

INTRODUCTION

Corona virus is a disease outbreak that causes death which makes it worse and basically in Indonesia it is explained in the disease outbreak law to spread and overcome it and also the quarantine method is explained in the Law of the Republic of Indonesia Number 4 of 1984 concerning Outbreaks of Infectious Diseases. Infectious disease, hereinafter referred to as an epidemic, is an outbreak of an infectious

disease in the community, where the number of sufferers has significantly increased beyond the usual situation at a certain time and area and can cause havoc. Sources of disease are humans, animals, plants, and objects that contain and/or are polluted, germs, and those that can cause epidemics. In an outbreak of this disease, the government should also know the medical records of a people whether it really happened, because a virus or congenital disease from an outbreak or this virus caused it. Medical record is a health record in the form of a book or patient data files received upon admission to a hospital, even medical records not only in Indonesia are used to record patients who enter the hospital for the first time. Indonesian citizens, starting from newborns to adults, should have a medical record track record which is important to find out about diseases or others, with that being seen and analyzing that when entering guidelines and to improve the economy in Indonesia, the government implements in every activity in an effort to maintain and improve the highest degree of public health. implemented based on non-discriminatory, participatory, and sustainable principles in the context of the formation of Indonesian human resources, as well as increasing the nation's resilience and competitiveness for national development. Anything that causes health problems for the Indonesian people will cause huge economic losses for the country, and every effort to improve the health status of the people also means an investment for the country's development. every development effort must be based on health insight, in the sense that national development must pay attention to public health and is the responsibility of all parties, both the government and the community.

Health is a state of health, both physically, mentally, spiritually and socially that enables everyone to live socially and economically productive lives. Resources in the health sector are all forms of funds, personnel, health supplies, pharmaceutical preparations and medical devices as well as health service facilities and technology that are utilized to carry out health efforts carried out by the Government, regional governments, and/or the community. Health supplies are all materials and equipment needed to carry out health efforts. the implementation of medical practice which is the core of various activities in the implementation of health efforts must be carried out by doctors and dentists who have high ethics and morals, expertise and authority whose quality must continuously improved through continuous education and training, certification, registration, licensing, as well as guidance, supervision, and monitoring so that the implementation of medical practice is in accordance with the development of science and technology.

The formulation of the problem in this study is to determine the importance of the role of doctors in the matter of the Law of the Republic of Indonesia Number 29 of 2004 concerning medical practice with the Regulation of the Minister of Health of the Republic of Indonesia Number 9 of 2020 concerning guidelines for large-scale social restrictions in the context of accelerating the handling of corona virus disease 2019 (covid). -19). Which affected the whole world from this infectious disease which resulted in the economy being crippled because of this corona virus. An epidemic of an infectious disease is where a disease that infects the whole community in large numbers which creates anxiety and there is no medicine to cure it even to prevent some Even in various countries there are regulations to prevent the wider spread of it, for example in Indonesia the Law of the Republic of Indonesia Number 4 of 1984 concerning Infectious Disease Outbreaks. This law was made in order to prevent the greater spread of the disease that will infect everyone.

Medical Records

Medical record is a medical record is a health record in the form of a book or patient data files received when entering the hospital, even medical records not only in Indonesia that use it to record patients who enter the hospital for the first time. even this medical record is used throughout the world to record patients admitted to hospitals abroad or in a country such as Indonesia, this medical record records where a person was born until he died which is where he entered the hospital for the first time. he entered that medical record This cannot be taken or accessed outside, because it is a patient secret, but the medical record has a medical resume.

Comorbid

A condition in which a person suffers from two or more diseases at the same time. The disease is generally chronic or chronic. In this era of pandemic, the role

doctors is important to provide of information to patients for the importance of medical records, suffered occurred because in this pandemic era many issues are scattered that make people uneasy, causing panic due to the Corona Virus disease outbreak, which causes a lot of panic and even issues that make people more worried and make immune resistance go down, and in this pandemic era a doctor should know that this patient is sick and died due to a comorbid disease or caused by the corona virus because of its transmission and the government should have when there is a pandemic, the government does not make people confused or afraid, even the government should reduce the issues that are scattered with the data. Even if there is a hoax spread in the community, there will be no panic in the presence of a pandemic, there is a corona virus, with the steps that the government has taken to be stricter against those who spread issues that make people more nervous, even the government should also make laws regarding protocols. health, and not closing businesses that make people struggle and ultimately weaken the economy, with the implementation of a protocol or other it can prevent and also the government also sees whether it is true that the patient who died was caused by the corona virus outbreak or a comorbid disease suffered by the patient. With this, the government can also suppress a budget or know about the death, with this patient anxiety in the community is reduced, even in a hospital medical records / medical records are very important for patients and families, with that we know the history of the illness of patients who suffer from this During the medical record or medical resume, the hospital provides a copy to the family for the purpose of knowing the illness suffered by the patient in their family to prevent issues such as death from the corona virus or due to illness he suffered and even the doctor should explain to the patient about the death or the interests of the patient. Stop asking questions outside the hospital in order to reduce rumors

circulating that are not true with the presence of either a virus or disease so as not to make people's immunity decrease.

Where each hospital has its own management where medical records may not be taken out, and where in exchange the hospital provides a medical resume which is a medical record in exchange to prevent leakage of patient confidential data but if the medical resume is lost it may be requested to the home sick again but there are Some hospitals will not give a second time if the letter is issued, but only some will provide another medical resume if the family asks for it depending on the hospital's policy, which is and where they were last treated as intended medical resume is useful as a continuation or history received by the patient, when you are out of the hospital, even on the medical resume of another hospital, you will know about the illness you are suffering from and you can continue to analyze it, either from your old or new illness.

Even some news shocked Indonesian citizens with the negative Rapid Test results and even being buried in the style of covid but basically the law that regulates to reduce hoaxes that occur in the community should be the government to determine how the existing rules so as not to cause crowds but basically more and more crowds. chaos in which community is used a rapid test or swab test so that people can bury their loved ones properly so that there are no regrets.

RESEARCH METHODOLOGY

The study conducted data collection with participant observation to find out in their life experiences and where some of the data was taken from a website from the minister of health which was used to find out the actual data according to a press conference published by an Institute website. Respondents were taken from an interview with one of the doctors at the Saiful Anwar Hospital to know his opinion about burials according to the health protocol and taking cases regarding whether the health protocol was carried out or not

and whether there were appropriate cases and whether this case also occurred or not. Sources of data in the study are the results of interviews where questions and answers competent carried out on appropriate sources in their fields and data collection from existing websites and is concerned with the existence of data from research in the form of government agencies and so on. To obtain the data needed in this study, the authors collected data through techniques interview by conducting questions and answers to related parties regarding the presence of the corona virus and handling during the burial of patients exposed to the corona virus and the importance of medical records. The author also uses data collection techniques with data collection where researchers can collect data from research with the same problem.

ANALYSIS & DISCUSSION

That the Regulation of the Minister of Health Number 47 of 2013 concerning Procedures for Preparing Draft Laws and Regulations in the Health Sector within the Ministry of Health needs to be adjusted to legal developments and technical needs for the preparation of legislation and other legal products in the field of Health. Regulation of the Minister of Health, hereinafter referred to as Permenkes, is a statutory regulation stipulated by the minister who administers government affairs in the health sector to carry out higher legislation or is formed based on authority. Decree of the Minister of Health, hereinafter referred to as Kepmenkes, is a decision that is stipulating and binding individually and/or in a limited scope determined by the minister who carries out government affairs in the health sector to carry out statutory regulations or is determined based on authority. The Program for Legislation in the Health Sector is a program planning instrument for the formation of Legislation within the Ministry of Health which is prepared in a planned, integrated and systematic manner. A certain problem that can be scientifically justified regarding the regulation of the problem in a draft law as a solution to the problems and legal needs of the community.

Medical Record Development

Medical records develop according to the progress of the times. Medical records themselves grow from conditions awareness of the importance of documentation for legal, medical, financial, educational and other purposes. In the medical field, documentation of patient data is very important, therefore every health service provided by doctors, nurses, midwives and other health workers must be recorded accurately and then managed in a medical record system. Good records reflect the health services provided. According to Edna K. Huffman (1981) in the Medical Record Administration, that a good medical record generally describes good medical care, while incomplete medical records reflect poor medical care. A quality health service must be supported by implementation of a quality medical record system so that patients feel safe and comfortable both with the services provided and in managing their health data. We as officers who want to study medical records must of course know what medical records are, how they develop, how they are organized to the legal aspects relating to medical records themselves so that later they can provide good data services to patients and medical record users. Finally, medical records coincided with the birth of medical science. Medical records themselves have developed since the stone age (paleolithic) approximately 250,000 BC. This is based on the discovery of carvings on the way of treatment at that time on the walls of the cave and the writings engraved in an old stone age cave in Spain. Other evidence that supports the development of medical records in the past to the present day is the remains of ancient Egypt (Egyptian Period), Greeks, Greek Romans, Byzantines, Jews, Prophet Muhammad up to the XXI century. These relics can be in the form of papyrus (documents), books, sheets and others.

Criminal Sanctions Rejecting Corpses of Covid Victims

The bodies of covid 19 patients are sometimes rejected by residents for fear of spreading the existing virus which makes families affected by the covid 19 disease feel confused where the family bury their family or relatives who died because of the covid 19 virus where sometimes there is a lack of education to the community to rejection and examples of "Cases" What recently happened was that people from the community rejected the body of a nurse who was tested positive for Corona at the Public Cemetery in Semarang Regency, which was reported by kompas.com. This incident adds to our concern, which is currently in the midst of the struggle of all parties against the Corona virus, especially those who are on the front line dealing with corona virus patients just for reasons of concern about the spread of the Corona virus. Regarding cases of refusal to bury the bodies of Covid-19 patients, the Government through the Police did not remain silent immediately followed up on residents who prevented those who carried out the burial of the bodies of Covid-19 patients. The Police will ensnare in layers of articles, namely as follows: Article 178 of the Criminal Code which states that "Anyone who intentionally obstructs or obstructs the entrance or transport of corpses to permitted graves, is threatened with a maximum imprisonment of one month and two weeks or a maximum imprisonment of one month and two weeks. a maximum fine of one thousand eight hundred rupiahs. application of this article is carried out if there is a refusal in an area, the police can immediately take legal action because article 178 of the Criminal Code is a general offense that can be followed up without a complaint first.

Article 212 of the Criminal Code which states that: "Anyone with violence or threat of violence against an official who is carrying out a legitimate task, a person who at that time according to statutory obligations or at the request of the official in

question is assisting him, is threatened for fighting the official with a criminal sanction, imprisonment for a maximum of one year and four months or a maximum fine of four thousand five hundred rupiahs. Article 213 of the Criminal Code which states that: "The coercion and resistance as referred to in articles 211 and 212 are threatened: With a maximum imprisonment of five years, if the crime or other act at the time resulted in injury; with a maximum imprisonment of eight years and six months, if it results in serious injuries; (KUHP 90). With a maximum imprisonment of twelve years, if it results in the death of a person; (KUHP 215, 487). Article 214 of the Criminal Code states that the coercion and resistance referred to in articles 211 and 212, if carried out by two or more people together, is punishable by a maximum imprisonment of seven years. (KUHP 460) states that the guilty are subject to a maximum imprisonment of eight years and six months, if the crime or other actions at that time resulted in injuries; imprisonment for a maximum of twelve years, if it results in serious injury; (KUHP 90) imprisonment for a maximum of fifteen years, if it results in the death of a person. (KUHP articles 215, 487).

Meanwhile, the application of these three articles is applied if the community refuses and there is resistance to the police and can become a new criminal element. Therefore, the public does not need to be afraid if the burial of the corpse of a COVID-19 patient is carried out in our area, because the Covid-19 Handling officer already has a special protocol by wrapping it in plastic so that the liquid from the body does not come out, the depth of the tomb is up to 1.5 meters. If everything is done, there is no need to worry." Whoever forces another person to do, not to do or to allow something with the threat of libel or written libel. In the case as formulated in point 2, the crime is only prosecuted on the complaint of the person affected by the patients, increasing number of the government issues regulations regarding large-scale social restrictions (PSBB).

Analysis of Hospital Allegations of Covid- 19 Patient

In connection with the re-occurrence of news that leads to public perception and opinion as if the Hospital "covided" patients, Indonesian the Hospital Association (PERSI) urgently needs to provide responses and clarifications as follows: 1) PERSI is committed and always supports the efforts of the Government and Regional Governments in dealing with the Covid-19 pandemic by providing health services for Covid-19 patients and general patients in need; 2) PERSI through its member hospitals is fully aware of its responsibilities to serve the health of the entire community, both Covid-19 and non-Covid-19 patients with all high risks in various aspects, both health and non-health; 3) In providing health services for Covid-19 patients, the Hospital upholds implements health services based on the provisions of the legislation and health protocols set by the Government and Regional Governments, in this case the Ministry of Health and other Authorities; 4) In terms of clinical management and management of corpses, hospitals guided by the guidelines set by the Ministry of Health, the last revision being the fifth which is stipulated in the Decree of the Minister of Health, Decree of the Minister of Health Number HK.01.07/Menkes/413/2020.

Case Analysis

"Allegedly Abandoned Patient, Indonesian Alliance Calls Charitas Hospital Inhumane Treatment" OKU TIMUR. Media AI-Pastor Sitorus came to the Aliansi Indonesia office and met directly with the Chairman of the Indonesian Alliance Kanda Budi Alliance, reporting the alleged neglect of patients without responsibility by the Charitas Belitang Hospital. The patient, Sugimin (86), who is the father-in-law of Pastor Sitorus, was allegedly abandoned by

the Belitang Charitas Hospital. Saturday (20/3/21). At the Indonesian Alliance Office, Pastor Sitorus said that patient Sugimin (86) came to Charitas Belitang Hospital on February 28, 2021. The patient is suspected of having been exposed to COVID 19 at Charitas Belitang Hospital and thus undergoing treatment in an isolation room. After being treated for 3 days in an isolation room, without a clear explanation and reason, the patient's family was forced to take the patient home without a referral and where to take him after being discharged from Charitas Hospital, while the patient was still in a sick condition. "It is very inhumane what Charitas Belitang Hospital has done, patients who are still sick are told to go home and without any referrals they have to be taken," he said. With a sad face, Pastor Sitorus continued his story, with great compulsion the family who felt sorry for the patient's condition finally brought the patient to one of the clinics in Belitang. Not later than 24 hours the patient finally died and was buried according to the COVID 19 protocol. Very unacceptable, a day later the PCR lab results from the Palembang Health Laboratory Center stated that the patient Sugimin was negative for COVID 19.

"The family's self-esteem feels like it's being trampled on because the patient was buried dishonorably because of the diagnosis of COVID 19 even though the patient was negative for COVID 19," he said in an annoyed tone. Pastor Sitorus added, the patient's family had several times asked for accountability from the Charitas Belitang Hospital to meet and resolve With this problem, one of the doctors at Charitas Hospital when meeting the patient's family apologized for the mistake. However, there was no official statement from the hospital and it seemed that there was no effort to solve the problem seriously. "We only ask for justice for the treatment of the Charitas Belitang Hospital, which has abandoned our parents, feel that it happened to your family (Charitas Hospital-ed)," he added.

In the same place, Kanda Budi Aliansi, accompanied by legal counsel for the East Indonesia Alliance, said that the Indonesian Alliance deeply regrets the treatment of the Charitas Belitang hospital, which is alleged to have abandoned the patient Sugimin (86), which is truly inhumane. The Indonesian Alliance will immediately send a letter to the Charitas Belitang Hospital to immediately resolve the problem by deliberation and consensus. "If there is no good faith from the hospital, the Indonesian Alliance will bring the alleged neglect of this patient to the realm of law and report it to the Ministry of Health," he concluded.

In a case above, which experienced by the late Mr. Sugimin, who was suffering from a disease caused by the corona virus, he did not get proper treatment and where it was also when people affected by the corona virus received treatment and the results were notified, which was experienced by you that the lab results were not was told if he was infected with the corona virus or not even at the end of his death that where the results from the laboratory explained the negative results were buried according to the covid protocol but where when the results were negative then instead of being buried, not according to the doctor's advice, even the host inside will die if the result is negative then the corona virus also dies.

CONCLUSION & RECOMMENDATION

The regulation was made to secure the good population in Indonesia because of the law of the Republic of Indonesia number 29 of 2004 concerning medical practice, the law of the republic of Indonesia number 36 of 2009 concerning health and the regulation of the minister of health of the Republic of Indonesia number 9 of 2020 regarding guidelines for social distancing on a large scale. In the context of accelerating the handling of the corona virus disease 2019 (covid-19) mutual support to make the economy in Indonesia not slump with this,

so that this country's economy will not have an impact on the economy of this country. Look again where the law explains whether it's a doctor or another and nothing states that the patient has corona but before the patient is said to be corona, it must first look at the medical record or copy in order to spread unrest in the community because people are increasingly afraid. There is a reduction in the immune system and as a government it is not allowed to limit the earning of a living so that there is no financial crisis in the citizens, unless there is a lack of income to the state so that the economic crisis does not occur, it makes citizens angry and the government should find a solution when quarantining citizens. It is better for the medical staff to do something where he has to record or ask for a medical record (medical copy) of each patient before performing surgery whatever so as not to misdiagnose a patient where is the use of a medical record (medical copy) if there is a new disease case, it turns out that it can be seen from the medical copy. there are heart, kidney, and hypertension diseases that have been suffered not from diagnosing new diseases such as Corona Virus 19.
